TERMS AND CONDITIONS

The completed, signed and dated booking form (overleaf) and these terms (including any incorporated terms), form a legally binding contract (Agreement) between the company or person named on the Form (Client or you) and Brumbies Rugby ABN: 54 156 410 155. This agreement sets out the terms on which Client will acquire, and Brumbies Rugby will supply, the Rugby Hospitality Package.

1. Rugby Hospitality Package

In this Agreement Rugby Hospitality Package means the hospitality package supplied by Brumbies Rugby to the Client on each match day at Canberra Stadium which includes admission to a match, the supply of a ticket and other benefits as noted by Brumbies Rugby.

2. Payment

- 2.1 As per chosen payment option.
- 2.2 All payments made by direct debit must be accompanied by faxed confirmation of said direct debit.

3. Cancellation

- 3.1 All cancellations must be in writing.
- 3.2 If the purchase of the Rugby Hospitality Package is cancelled by the Client the following refund policy will apply a) 100% refund of payments should the Rugby Hospitality Package be on sold or b) 50% refund of payment should the Rugby Hospitality Package not be sold.
- 3.3 Brumbies Rugby may cancel the Rugby Hospitality Package without notice if you are in material breach of any provision of the Agreement.
- 3.4 Brumbies Rugby will not be liable for any loss or damage arising out of the cancellation of the Rugby Hospitality Package pursuant to clause 3.3

4. Indemnity

- 4.1 The Client will indemnify Brumbies Rugby against any loss or property damage to Canberra Stadium arising out of the Client's use of the Rugby Hospitality Package and for any personal injury, death or loss or damage to any property or any person arising out of or as a consequence of your use of Canberra Stadium or services except that such loss, damage, injury or death arises from negligent act or the omission of Brumbies Rugby.

5. Distribution of the Hospitality Package

- 5.1 Brumbies Rugby will distribute tickets, hospitality passes if required and other information to Client approximately 14 days prior to the relevant match provided full payment has been received.

6. General Conditions

- 6.1 Client must ensure that each of its guests and ticket holders:
 - (a) do not erect, fix or display any goods, materials, advertisements or promotional material in, on or around Canberra Stadium, without the prior written consent of Brumbies Rugby;
 - (b) comply with all reasonable directions given by Brumbies Rugby and Canberra Stadium from time to time (and obligations referred to in the Privacy Notification below);
 - (c) comply with all ticket conditions specified on tickets issued as part of the Rugby Hospitality Package; and
 - (d) do not use the Rugby Hospitality Package for any purpose other than that for which it was sold. Without limiting the generality of the foregoing, it is a condition of sale that any Rugby Hospitality Package or part thereof will not be re-sold, on sold, sublet or rehired nor used for advertising, promotion or other commercial purposes (including competitions or trade promotions) or to enhance the demand for other goods or services, without the prior written consent of Brumbies Rugby. Any breach of this clause will result in the cancellation of the existing Rugby Hospitality Package without a refund.
- 6.2 The client agrees and acknowledges that Brumbies Rugby enters in this agreement in its own right and as the agent and trustee for the Australian Rugby Union Limited (ARU). The client agrees and acknowledges that the ARU may independently enforce this agreement against the client.

PRIVACY NOTICE

Information about Ticket Holders and other individuals

In providing the Rugby Hospitality Package under this Agreement Brumbies Rugby may seek and collect personal information, including sensitive information (as those terms are defined in the Privacy Act 1988 (Cth)) from the client about third parties, including the holders of Tickets.

The Client must provide all notifications and obtain all consents required by the Privacy Act to enable Brumbies Rugby to collect and otherwise handle information about individuals lawfully, as required for Brumbies Rugby business (including marketing), and without taking any further steps. This may require Client to inform those third parties of the matters set out in this Privacy Notification or of other matter advised by Brumbies Rugby to the Client from time to time.

Information collected

In the course of conducting its business Brumbies Rugby may collect personal and sensitive information about individuals including the names, professional positions and contact details of attendees at matches and hospitality events, details of the company, firm or entity with which the attendee is associated including the relevant business unit, and details of any special requirements.

Use and disclosure of personal information

Brumbies Rugby may share personal information with third parties including associated local and overseas entities, professional advisers and organisations with whom they have co-promotional arrangements (and any third parties used in administering those arrangements). Brumbies Rugby may also share personal information with other service providers including organisations that assist them by providing archival, auditing, professional advisory, data and document processing, mailing delivery, technology and security services.

In addition to providing services Brumbies Rugby may use and disclose personal information if required by authorised by law and for purposes related to research, planning, service development, security and risk management and as otherwise permitted by the Privacy Act.

Brumbies Rugby may also use and disclose personal information to keep individuals informed of their services event and other matter with they consider may be of interest to them, and to build and maintain a relationship with individuals. Individuals can advise Brumbies Rugby that they do not wish to be contacted for those purposes, by contacting Brumbies Rugby Privacy Officer whose details appear below.
